	intellectual, emotional, social, and moral values. The college makes appropriate use of ICT in curriculum development process. College follows value added courses and offers elective papers then and there to enhance the all round personality students teachers. The college follows the syllabus framed by Tamil Nadu Teachers Education University. One of the faculty is a member of the Academic Council. The syllabus is revised by the University once in Three years.
Teaching and Learning	The College organizes as orientation programme for the fresher's at the institution and department level. Mentoring, tutoring, counselling, remedial classes are provided to students. Special programmes are arranged to cater to the needs of advanced learners. The IQAC conducts a student appraisal of teachers, and takes a parent feedback to evaluate the teaching learning process at the institutional level and suggest measures for improvement.
Examination and Evaluation	The IQAC monitored and periodically evaluated the activities of the Examination Cell to ensure the continuous and comprehensive evaluation of students and the timely conduct of examinations. Examination marks were scrutinized and displayed to assess learning outcomes and identify areas and strategies for improvement.
Research and Development	The faculty members were encouraged to engage in activities that promote research and development and strengthen consultancy services. In its efforts to train, motivate and reward faculty, the institution encourages members to attend Short term courses/refreshers co urses/conferences/workshops/seminars/Fa culty development programmes/training programmes, etc, and to be research oriented. Human Resource Management	All the teachers are highly qualified and dedicated to their profession. They update themselves by attending various courses like refresher course and short term courses. They also organize seminars and workshops. In its efforts to train and motivate faculty, the institution encouraged members to attend courses/conferences/workshops/seminars/training programmes, etc, and to be research oriented.
Industry Interaction / Collaboration	Atleast 20 schools are involved in giving practice teaching to the prospective teachers. B.Ed. students visit schools for hands on training. The student teachers help the schools by contributing to the teaching learning process in the schools where there are many teaching vacancies. The guide teacher and Head master of the schools help the students by providing useful suggestion for improvement and feed back on their teaching performance.

1.Title of the Practice: Improving Teaching - Learning Process 2. Goal: • To ensure the completion of syllabus according to the academic planner of each department • To encourage teachers to adapt to technological advancements including ICT adoption in class room teaching • To improve pass percentage and enhance the number of ranks at the university level examinations 3. The context : • The syllabus coverage in some cases is being hurried and towards the end of the semester where information are being crammed at once. This sluggish coverage initially and hurried coverage later should be avoided giving enough time to student in comprehending the topics and assimilating the facts. • It has become essential for some of the teachers to adopt to the latest pedagogic styles and include ICT in class room teaching. The mismatch between the student learner and the teacher in the use and comfort of handling varieties of tools available for teaching - learning needs to bridged. 4. The practice: • Academic planner is issued to the students for information. • The teaching - learning committee along with the heads of different departments monitor the pace of coverage of the syllabus. • Informal feedback is obtained from students regarding the content delivery by different teachers. The teaching - learning committee members and the class teachers hold frequent informal meetings and cull out the information needed. • Frequent assignments, tests and evaluation are conducted to improve performance in the semester - end examinations • Four class rooms are made ICT ready and many departments have the necessary tools for handling the class room teaching with the help of ICT. 5. Evidence of Success: • Some of the teachers have adopted modern pedagogic styles and ICT in their classes. • Some of the notes are uploaded on the college website. • Appropriately paced and timely completion of syllabus • Increased attendance in the classes • Improvement in results. 6. Problems encountered and Resources require: . • Development of animation based power point presentations in teaching, particularly in science subjects, has been hindered due to the want of in - house technical expertise. ullet The demand for ICT resources is increasing

and paucity of funds has been the biggest impediment which may dampen the spirit of technology adoption by teachers. Best Practice - II 1. Title of the Practice - Enhancement of Placement 2. Goal: To help the students to realize their primary ambition of getting employed on graduation, efforts have to intensified to arrange campus interviews and prepare our students to emerge successful in them. Different strategies, ranging from curricular updation to training programmes for students have been organized. A realizable target of securing employment for a minimum of 25 of our graduates has been set for the year 2017-2018. 3. The Context: Students, during the first year of their graduate studies are not motivated to set goals. Only during the last semester they give serious thought to their future and feel frustrated as they realize that they have not taken advantage of the opportunities provided in the campus to acquire employable skills. Hence it has become imperative to counsel and encourage them to set definite goals and work towards achieving them from day one of their tenure in the campus. Placement has been improved through the following efforts • Appointing a placement officer and establishing a placement cell with one staff. • Counselling for outgoing students on Bio-data Job application and preparation of Job Prospects. • Impressing on them the acquisition of relevant skills needed for specific jobs. • Creating a Career corner in the Library with posters for competitive examination, collection of current books for preparation of these examinations etc. • Display of details on jobs related to the field of study, on the notice board of departments, • Offering General Courses for Communication skills, Personality Development and Confidence building exercises 4. The practice: Students with career ambition and the potential for employment will be identified after the first semester. They will be motivated to improve their academic profile and join courses that will reinforce their employable skills. By the fourth Semester, the cumulative acquisition of these skills along with the confidence they had gained through mind set, will make these students winners increase our percentage of placement.
